2021 - AFRICA LUDO CLUB CHAMPIONSHIP GUIDELINES:

1. All Games will start promptly as at **10:00am, 12:00, and 12:00 noon** for day one, two and three respective, and the first game set will be counted a walkover the missing team after 5th minute.
2. Upon getting a **RED-CARD** the victim/player will miss the next four consecutive sets.
3. The standard Game time (Duration) shall be one **hour only** with two recess periods at the **20 and 40 minutes** mark respectively.
4. A player shall start or enter as substitute, **not more than four times** on each match day.
5. Only registered players as per the **ALCC-21 online Team sheets**, shall be allowed on board.
6. The games shall be played on **sets basis** not points.
7. The best two teams with the highest sets (sporting Merit) will be declared as **semi-Finalists**.
8. At knock out stages the winner group **A** will play against the second from group **B** and winner group **B** will play against the second group **A**
9. Match day one the game shall have **six sets** played.
10. Match day two the game shall have **four sets** played.
11. Match day three the game shall be played on a **best of five sets** basis.
12. The best two teams will qualify to take part in ALCC group stages expected in March, **2021**.
13. In case of any dispute, a written petition, with a nonrefundable fee of **USD15\$** shall be filed with the Ug-ALCC-21 competitions desk not later than 24 hours.
14. Fans, supporters and well-wishers shall **not be allowed** at the playing venue.

STANDARD OPERATING PROCEDURES (SOPs):

- ❖ All players shall be scrutinized in accordance to **COVID 19** free - procedures
- ❖ All players shall have on, hand gloves, face masks, and the expected temperature norm.
- ❖ All players shall be on closed shoes with decent dressing.
- ❖ All Participants are requested to keep social distancing as demarcated by the organizers.
- ❖ **NB:** Failure to meet the SOPs can lead to individual/team **expulsion from the venue**
